

life threatening and related illnesses and ailments. Born out of the hardships experienced by one of Becker & Poliakoff's partners when his daughter fought a (fortunately successful) battle for her life against cancer, Becker & Poliakoff Helping Hands now enthusiastically delivers toys to children with serious illnesses in an event that has grown so large that it frequently attracts media attention. Becker & Poliakoff Helping Hands, as a not-for-profit corporation, is privileged to provide tax deduction opportunities for donors complying with the requirements for tax deductions.

Every year, volunteers from Becker & Poliakoff, after year-round fundraising and campaigning for donations, visit hospitals around the state, including our signature event over the winter holidays during which we are accompanied by a cast of professionally costumed characters. They join Santa Claus as he strolls the halls of cancer and terminal pediatric wards and deliver free toys, including high-end electronics that many of the families from lower socio-economic backgrounds could not afford on their own.
